

## REQUIREMENTS FOR USE OF THE CERTIFICATION LOGO RCC

These regulations relate to the certification logo for RCC certified organizations. The certification logo is managed by the Registracion di Companianan di Construccion (RCC) Fundacion.

The certification logo as shown in this document may be used by certified organizations according to the mentioned regulations below.

The Fundacion will provide the certified organization with an electronic image of the approved logo or can copied from this document.

The use of the certification logo is strictly limited to the organization whose application has been successfully certified according the standard.

In case of incorrect use of the certification logo, the Fundacion may withdraw or suspend the certificate and the right to use the certification logo.

The Fundacion reserves the right to change these regulations at any time and will then notify the certified organizations in writing of any changes in the regulations.

### USE OF THE CERTIFICATION LOGO

The certified organization that uses the certification logo agrees that:

- the certification logo may only be used in accordance with the instructions in this document and in the certificate.
- the certification logo will only be used with regard to the scope of what is stated on the certificate.
- the certification logo may only be used on office supplies such as letterheads, business cards, invoices, displays, company posters or on TV spots, websites, brochures, or vehicles of the certified organization.
- on all means of communication such as flags, products, packaging, shop window stickers, promotional items such as pocket diaries, coffee cups, coasters, doormats, etc ... the certification logo may not be used.
- when the certification logo is placed on a website, the certification logo must be used as a hypertext link to the following URL of the Fundacion: <http://www.fundacion-rcc.com>
- in case of suspension, withdrawal or cancellation of the certificate, the use of the certification logo or any reference to must be immediately discontinued, and that no copy or imitations will be used.
- during the validity date of the certificate or after it, it will not claim the ownership rights of the certification logo.
- the certification logo may not be modified.
- in connection with the management, maintenance and development of the standard, a payment is due to Fundacion RCC for the use of the certification logo / logo. This payment is included in the contribution for certified organizations.
